

PRIVACY POLICY

Based on Article. 13 sec. 1 and sec. 2 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / EC (general regulation on the protection of personal data called: "GDPR", we would like to inform you about the method of processing personal data on our website.

1. General information.

1. The operator of the website www.fyestudios.com is FYE Software FZ-LLC, FDB50316 Compass Building, Al Shohada Road, AL Hamra Industrial Zone-FZ, Ras Al Khaimah, United Arab Emirates, Licence No 47011556
2. The website obtains information about users and their behavior in the following way:
 - Through information entered voluntarily in forms
 - Through cookie files saved in end-devices (so-called "cookies").

2. Information in the forms.

1. Service collects information provided voluntarily by the user.
2. The website may also save information about connection parameters (time stamp, IP address, purchases on the website www.fyestudios.com)
3. The data in the form is not shared with third parties.
4. If the data in the form enables the identification of a natural person, such person has the right to access, modify and request to stop processing his data at any time. It is possible, however, that this will result in the lack of access to some of the website's functions.
5. The data provided in the form are processed for the purpose resulting from the function of a specific form, e.g. in order to process the user and add additional functions for the use of the website.
6. The data provided in the forms may be provided to entities that technically provide certain services, such as payment services or other entities with which the Website Operator cooperates in this respect.

3. Information about cookies.

1. The website uses cookies.
2. Cookie files (so-called "cookies") are IT data, in particular text files, which are stored on the Website User's end device and are intended for using the Website's pages. Files of this type usually contain the name of the website they come from, the storage time on the end device and a unique number.
3. Cookies are used for the following purposes:
 - Creating statistics that help to understand how Website Users use websites, which allows improving their structure and content;
 - Maintaining the Website User's session (after logging in), thanks to which the User does not have to re-enter the login and password on each subpage of the Website;
 - Determining the user's profile in order to display advertising materials that are matched to this profile, in particular the Google network.

4. Software for browsing websites (web browser) usually allows cookies to be stored on the User's end device by default. Website Users can change the settings in this regard. The web browser allows you to delete cookies. It is also possible to automatically block cookies. Detailed information on this subject can be found in the help or documentation of the web browser.
 5. Restrictions on the use of cookies may affect some of the functionalities available on the Website pages.
 6. Cookie files may be used by advertising networks, in particular the Google network, to display advertisements tailored to the manner in which the user uses the Website. For this purpose, they may keep information about the user's navigation path or the time spent on a given page.
 7. In terms of information about user preferences collected by the Google advertising network, the user can view and edit information derived from cookies using the tool: <https://www.google.com/ads/preferences/>.
4. **Server logs.**
1. Information about some of the behaviors of users are subject to logging in the server layer. These data are used only to administer the website and to ensure the most efficient service provided.
5. **Data storage opt-out.**
1. The user may voluntarily opt out of storing his data by the website. To do this, please send a letter of resignation in which we will provide all the data necessary to verify your application.
